PI1 polyol is designed for production of Rigid Foam for Insulation. The polyol contains all additives including blowing agent 141b and flame retardant. This polyol react with isocyanate with good characteristics. The system meets the FR B2 standard.

Storage

Hygroscopic. Use dry nitrogen or low dew point air for tank padding. Keep drums



tightly closed to prevent contamination. Store at $15\sim25^{\circ}$ C. Observe all federal, state and local regulations when storing this substance. Store away from incompatible substances.

Shelf Life

Under recommended storage conditions, the shelf life of PI1 is 6 months. If the production is overdue, but it's main physical and chemical properties in the guide line, may not effect on its using properties.
